Dear FEC Analyst,

Today, February 12, 2022, I electronically filed my FEC Form 2 that officially declares my candidacy for the 2024 U.S. Presidential Election.

In the 2024 U.S. Presidential Election, I will continue to advocate for my proposal from the 2020 U.S. Presidential Election to reform our existing Social Security & TANF (aka Welfare) programs into a single Price Support for Labor that is BOTH means-tested AND only pays for hours NOT worked (out of a max of 40 per week per person). Under this plan, I will continue to propose hour-rate benefit thresholds that encourage working-age recipients to remain in the work force part-time (roughly 20 hours per week) in order to maximize the value of their income plus benefits received.

As part of this process, I filed my Form 2 for the 2024 U.S. Presidential Election as an amended Form 2 under my previous candidacy in the 2020 U.S. Presidential Election (Candidate ID P00011395), using the same committee that I used for the 2020 U.S. Presidential Election (Ryan 4 Prez, FEC Committee ID C00703512). Also, I updated my Party Affiliation to Republican as well, so as to reflect the fact that I will be running as a Republican in the Republican Party Primary.

Based on my current understanding, I believe this was the most correct way to file a Form 2 for a new presidential election season. Please alert me if my understanding was flawed or if there is further action that I must undertake.

Also, currently, I do not plan to raise or spend funds for the entirety of the 2024 U.S. Presidential Election, so I do not expect to trigger FEC automatic reporting requirements, and so I do not plan to submit quarterly reports to the FEC. I will keep your office updated if my situation changes.

Finally, I ask that you please add this letter to the record of filings for Candidate P00011395 and Committee C00703512. Also, please let me know if any further action is advised or required, and thank you in advance for your efforts on my behalf.
