Dear FEC Analyst,

On April 12, 2022, I received an email from the FEC that encouraged me to file a statement by April 15 that my campaign committee has NOT met or exceeded the \$5000 reporting threshold for money raised or spent that triggers the formal reporting requirement.

My campaign committee has NOT met or exceeded this \$5000 threshold, and I am submitting this letter as a statement to this effect. Furthermore, I do not plan to meet or exceed this threshold over the entire course of the 2024 U.S. Presidential Election, as I am not actively raising or spending money and I primarily campaign on Twitter (which is free to use).

As an example of my Twitter campaign activity, recently, I have proposed that for owners of Miniature Mobile Homes (i.e. Mobile Homes under an 8 foot by 32 foot size limit) who use such Mobile Homes as their sole residence, that the Federal Government provide a guaranteed plot of land on which the owner may place such a Miniature Mobile Home.

The exact location of such a plot of land may change over time, so the owner of the Miniature Mobile Home must keep the home readily mobile. This is part of the rationale for the 8 foot by 32 foot size constraint, which guarantees that the home shall be capable of being towed by a standard tractor trailer on most roads within the U.S.

Also, such a plot of land shall have access to the minimal amenities needed for sanitary living (e.g. pay-per-use toilets and showers). If an owner of a Miniature Mobile Home desires greater amenities, that owner must move their home to a privately-owned Mobile Home Park that offers such amenities.

This program shall be enacted in such a manner as to remain compatible with my previously proposed Price Support for Labor. An owner of a Miniature Mobile Home that accesses a federally guaranteed plot of land would at the very least be expected to cap their labor output at 40 hours per week, and possibly be expected to trade 10 hours per week of labor output for access to the federally guaranteed plot of land (yielding a maximum labor output of  $40-10=30$  hours per week).

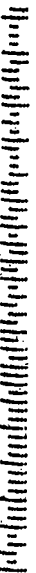
